Rundown

- Target session times for approximately 35 minutes. Co-hosts will promptly start meetings at scheduled time
- Co-hosts will introduce themselves but should not to do a sales pitch
- Depending upon the number of persons, co-hosts may decide that each person in the room should introduce themselves
